IN 2019, WE SERVED MORE THAN 700 NONPROFITS THROUGH THE ACCOUNTABILITY WIZARD AND DIVERSITY, EQUITY, & INCLUSION TOOLKIT, WITH 80% OF NONPROFITS IN THE ACCOUNTABILITY WIZARD THAT MET STANDARDS INDICATING THAT THE REVIEW PROCESS HELPED POSITION THEIR ORGANIZATION TO "BETTER/MORE EFFECTIVELY WORK TOWARD ITS MISSION" (UP FROM 79% IN 2018). IN 2019, WE CONTINUED TO USE SOCIAL MEDIA AS A PLATFORM TO CONNECT DONORS, FUNDERS, AND NONPROFITS, WITH INCREASED ENGAGEMENT RATES ON TWITTER, LINKEDIN, AND FACEBOOK. WE HOSTED FORUM 2019: BREAKING PATTERNS, A CROSS-SECTOR EVENT FOR MINNESOTA'S MOST ENGAGED CIVIC-MINDED LEADERS, WITH 83% OF SURVEY RESPONDENTS INDICATING THAT THEY WERE "VERY LIKELY" TO ATTEND A FUTURE CHARITIES REVIEW COUNCIL EVENT. 17% INDICATED THEY WERE "SOMEWHAT LIKELY."
