IN 2022, WE INCREASED THE NUMBER OF NONPROFITS SERVED BY 7% THROUGH THE ACCOUNTABILITY WIZARD AND DIVERSITY, EQUITY, & INCLUSION TOOLKIT. THE NONPROFIT SECTOR HAS MANAGED A GREAT DEAL OF AMBIGUITY IN THIS COVID ERA AND ITS RESULTING ECONOMIC IMPACTS. THE COUNCIL REMAINS A SOURCE OF SUPPORT FOR OUR NONPROFIT PARTNERS WITH CAPACITY BUILDING RESOURCES.
